ESF History and Role

- ESF established in Strasbourg in 1974
- ESF is an independent, <u>non-governmental</u> organisation
- Offices in Strasbourg and Brussels
- Budget: € 41 Mio.
- Budgets networked through ESF:
 € 1-3 Bio.
- Potential budget leverage: MOs

- Research Conferences (45k€ each);
- Forward Looks (150k€ each)

Synergy: "advance at European level"

- Research Networking Programmes (>500k€ each);
- EUROCORES (5-12 M€ each)
- Research Infrastructures

Management:

- COST (ca. 210 M€); EuroBioFund (ca. 2 M€); EURYI (ca. 100 M€); ERA-Nets (ca. 10-20 M€ each)





European <u>CO</u>operation in the field of <u>S</u>cientific and <u>T</u>echnical research

- Origin:
 - -Started 1971: Ministerial Conference,
 - 19 Member States
- Current Participation:
 - -2006: 34 COST Member States +
 1 cooperating state (Israel)
- •COST Actions:
 - -Concerted Actions (Networks) of nationally funded R&D projects [all fields of research]



EUROCORES – ESF European Collaborative Research Programmes

- <u>ESF</u>: "responsive mode"
- <u>European</u> (plus)
- Collaboration: transdisciplinary; multilaterally transnational; researchers AND funders
- Research: basic research; working together, not "just" meeting
- Programme: addressing largescale issues; offering opportunities to exlore wide-ranging, multiperspective approaches

EUROCORES Programme TECT: aims and topics

- Build a multidisciplinary research framework, integrating methods and disciplines;
- Improve the fit between theory and data: generate new theoreical insights; expand range of empirical observations, on which models can be tested;
- Study evolutionary, historical, developmental origins of cooperation and trading;
- Explore mechanisms at the basis of cooperation (incl. cognitive foundations)
- Build biological model systems of human cooperation and trading;
- Transversal themes: reproductive behaviour; the role of communication; collective action and power



EUROCORES Networking: why?

- Programme coherence
- Programme visibility

Main overall objective:

- Strengthen the field (capacity building)
- Discover new science horizons (perspective creating)



EUROCORES Networking

Programme coherence

- Promote development of synergies between funded CRPs
- Explore programme aspects in the Call that are not covered by the main research foci of the selected CRPs

(also by forging links to recommended but not funded projects)



EUROCORES Networking

Programme visibility

- Promote the contribution of the field to wider areas of participating disciplines and areas of knowledge;
- -Promote interdiscipinary approaches;
- -Promote the field in countries not participating in TECT;
- -Promote the benefits of international research collaboration.

Strategic workshops; publications; reports



EUROCORES Networking and Dissemination: what?

- Joint science meetings: workshops; symposia; conferences; sessions at conferences; summer schools etc.
- Support for joint publications (working papers series?)
- Support for strategic workshops
- Mutual research visits between CRP's (also of different EUROCORES)
- Dissemination support (TECT sessions or representation at larger science events)
- "PR" support (e.g. web exhibition)



EUROCORES Networking & Dissemination: boundary conditions

Overall: usually 10% of research funding; currently provided through ERA grant from EC

Specific:

- Workshops: minimum 2 CRPs involved (value € 15.-25.000)
 financial responsibility of local organiser; scientific report required
- Co-sponsorship welcome
- Working visits between CRPs in Europe
- Dissemination (TECT representation) worldwide) [up to six travel grants p.a.]

Contributions to "PR" material required



EUROCORES Networking & Dissemination: how?

- "Light-weight application" (timeline; format verified with Coordinator)
- Scientific Committee (PLs + Coordinator + other members) discusses merit / suggests changes
- Final decision with ESF
- Acceptance form
- Payments (80-20)
- Scientific & financial report



EUROCORES Networking & Dissemination: now!

...during TECT launch conference:

- Present Collaborative Research Projects (CRP's);
- Discuss science perspectives;
- Discuss networking / dissemination options during Scientific Committee meeting (7 July 2007)
