

- MO Forum on European Alliance on Research Career Development (Action N°2)
 - The European Commission "Towards a European Framework for Research Careers" to be submitted to the European Council during 2011 to adopt the descriptors of the career taxonomy proposed in the Forum's report
 - Input into the European Commission's Mapping Exercise on Doctoral Training in Europe

 - WG2 Skills VITAE career development framework feasibility pilot project, September – December 2011, across Europe

Design and produce a set of indicators that could account for the internationalisation of European research activities and programmes.

- Provide a conceptual framework
- Involve MOs in a collaborative project: develop indicators for their own needs
- Develop a set of indicators adapted
 - to the different types of MOs,
 - to their different missions,
 - to the different research domains.
- Take into account the work and expectations of the European Commission on indicators and internationalisation.
