- 1. Lara Sels (LS) accepted to take care of the final revision of the case studies and to give them a coherent layout. We decided to order them alphabetically. Authors have been asked for illustrations of the case studies, but not many answers have been received so far.
- 2. We decided that all members of the editorial board of the chapter should be considered editors of the chapter, and not only the Team leader. We proposed some elements to be added to the introduction and divided the task of writing them between Johannes den Heijer (JdH), Jost Gippert (JG) and Sébastien Moureau (SM). Alessandro Mengozzi (AM), who was unable to be present, will be the main responsible for the introduction.
- 3. The methodological part of the chapter was discussed, paragraph per paragraph, several elements were added or revised during the meeting.
- 2.1 and 2.2 only need a final editing, which is the responsibility of Caroline Macé (CM).
- 2.3 and 2.4 need more work, but this should be finished by February 9 (also responsibility of CM).
- 2.5 has been mostly written by SM, and is now revised by JdH, with the help of CM.
- 2.6 has been added recently and is being written by CM and JdH. All the work must be finished by February 12, then CM will give it a final look and send everything to Evgenia on February 14 before noon.
