Pr. Vladimir A. Mau is Rector of the Academy of National Economy under the RF Government, Doctor of Economics, Professor, PhD (Université Pierre Mendès France), the Honored Economist of the Russian Federation, a member of the Editorial Board for *Voprosy Ekonomiki* (Problems of Economics) journal, the *Mir Rossii* (Universe of Russia) journal, and the *RAND Journal of Economic Transition*. He also holds membership in the Scientific Council of the Russian Academy of Sciences on Russian and World Economic History. Since 1991 V. Mau has contributed to design and implementation of the course of Russian economic reforms; in 1992-1993 he was Counselor to the Prime Minister of Russian Federation; in 1997-2002, V. Mau was Head of the Working Center for Economic Reform under the RF Government and he is the Deputy Director of the Institute for the Economy in Transition. He is currently head of the advisors committee for the Anti-crisis policy of Prime Minister Putin. Pr. Mau has published about 250 articles in various publications concerning history of economic thought, political economy, social and political issues of market reforms, economic policy, etc. His research and major findings focus on economic history and the history of economic thought in Russia and the USSR, the theory and history of economic policy, including the period of NEP, evolution of the economic system of the USSR, and the record of reforming the economic mechanism. In his works, V. Mau pays a particular attention to analysis of current challenges facing Russia's economy and long-term trends of its development. He has been among pioneer researchers into the Russian problems of constitutional economy and developers of a new avenue of research of transformational economic processes known as the political economy of reforms. His research findings have been summed up in several books such as: *The Political History of Economic Reform in Russia, 1985-1994*. (London: CRCE, 1996); *The Challenge of Revolution: Contemporary Russia in Historical Perspective* (Oxford: OUP, 2001), " *Velikiye revolutsii*" ("Great Revolutions", Moscow: Vargius, 2004),

James MAYALL

After a period as a National Service Officer in West Africa and six years in the British Civil Service, including a period in the British High Commission in New Delhi, James Mayall taught International Relations at the London School of Economics and Political Science between 1966 and 1998. From 1991-94 he was Convenor of the Department of International Relations and until 1998 Chairman of the Steering Committee of the Centre for International Studies and of the Editorial Board of the series of LSE Monographs in International

Studies, published by Cambridge University Press. In June 1997, he was appointed as the first Sir Patrick Sheehy Professor of International Relations in the University of Cambridge. He became Director of the Centre of International Studies in January 1999, and was elected a Fellow of the British Academy in 2001.

During his career, James Mayall has written and published widely on the international relations of African states, North-South relations, international theory and the impact of nationalism on international relations. His *Nationalism and International Society* (Cambridge University Press, 1990) won the Political Studies Association's prize for the best monograph of the year. Over the past decade his research and writing has concentrated on the resurgence of ethnic, national, and religious conflicts since the end of the Cold War and the international reaction to them. In 1996 he edited and contributed to *The New Interventionism 1991-1994: United Nations Experience in Cambodia, former Yugoslavia and Somalia* (Cambridge University Press), and in 2000 published *World Politics: Progress and its Limits* (Polity Press). He is currently working on a sequel to this book, tentatively entitled *Progress and Tragedy in International Relations: Making sense of September 11 2001*, and a longer term project dealing with the impact of the end of empire on international order.

Guenther SCHLEE

Günther Schlee was until 1999 Professor of Social Anthropology at the University of Bielefeld, having studied anthropology, romance languages and general linguistics in Hamburg. He received his doctorate for research on the belief and social systems of the Rendille, an ethnic group in northern Kenya. Alongside widespread fieldwork in Kenya, Ethiopia and Sudan, he was also guest lecturer in Padang (Sumatra) and at the Ecole des Hautes Etudes en Sciences Sociales in Paris. Typical of the research of Günther Schlee is the 'inter-ethnic' procedure and the combining of historical, sociological and philosophical methods.
